## **NOTES FOR ALL (when applicable)**

**Verification of Residence:** Verification of a parent's/legal guardian's residence via a Statement of Bonafide Residence (FM-7444) shall be required at the time the child registers in a District school.

### **Evidence of Custody/Guardianship**

- If the parent lives within Miami-Dade, Broward, Palm Beach or Monroe counties, the parent must provide documentation of custody by an appropriate state agency such as the Florida Department of Children and Families or the court, To obtain guardianship of a student, the legal parent must submit to the school a power of attorney that has been properly executed by the legal system, the receipt of affidavit from the Family Courts and valid photo identification. Applications for temporary custody of minor children by extended family can be obtained at the Lawson Thomas Courthouse at 175 NW 1st Ave., Suite 24419 Miami, Florida, 331289 (305) 349-7800.
- If a parent resides within Miami-Dade, Broward, Palm Beach or Monroe counties and the student lives in a residence licensed by the Florida Department of Children and Families, the student may be registered and enrolled in the school that serves that licensed residence.

**Florida Statute 837.06, False Official Statements,** states that any parent who knowingly makes false statements in writing with the intent to mislead a public servant will be penalized by law.

**School Board Policy 5112-Entrance Requirements** establishes the admission and registration requirements for students entering school.
