Decals will be sold by PTSA.

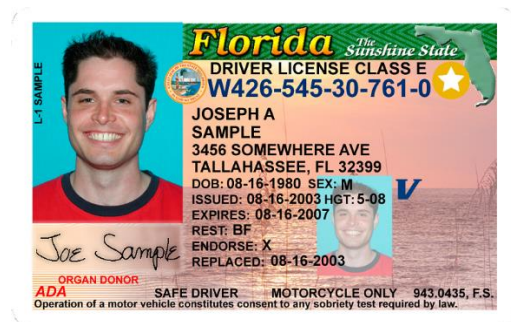
To buy the decals, you must bring:

### STUDENT PARKING PERMIT INFORMATION Rules and Regulations for Students Using Parking Decals

1. **Students will be registered to park their car in the school lot only.**
2. In order to obtain a student parking decal, you must have:
  - a. Valid Driver License Class E (**no learner's driver license**)
  - b. Student Identification Card
  - c. Current valid insurance card or declaration page with student listed as insured, and.
  - d. Current tag registration.
3. Parking decals are **\$15.00** and are valid for the **2021-2022** school year only.
4. Decals **must** be displayed properly, from the rear-view mirror with the number showing, while parked on school grounds.
5. The speed limit is **7 MPH**. **Speeding and reckless driving will result in the loss of parking privileges.**
6. Students found parking in areas not designated for student parking will be subject to disciplinary action. **Under no circumstances can a student park in areas numbered, and /or marked faculty/staff or handicapped parking.**
7. **Decals are non-transferable.** Decals will be taken from anyone who has possession of one not assigned to them.
8. **Students may not go to their car during the school day, including lunch, without the prior written permission of an administrator and/or designee.**
9. Any information on the form found false may result in the loss of parking privileges.
10. **Violation of these rules will result in the loss of parking privileges, fines, and/or towing.**
11. **In the event, your parking privileges are revoked there will be no refund.**
12. **Felix Varela assumes no liability for any theft or damages to vehicles.**
13. Felix Varela **will not** be responsible for any legal repercussions if your vehicle is parked in any other surrounding public and/or private parking areas not designated as permitted parking area.
